




2- Question 5: Considering the example above, if you would like to improve this label, what would you prefer? (Only one answer possible) (N = 573), values = percentage (count)¶








Economic impact of five policy options





Health, safety and env impact of 5 policy options



Purchase of detergents in bulk




Figure 6-9: Question 7: Imagine you buy a detergent in bulk in a grocery. You have brought your own bottle which does not bear a label for this detergent. What would be the best option to inform you on the hazards and safety instructions? (Only one answer possible) (N = 586), total responses for Source: Analysis of OPC responses



Questions



b1) **For unpackaged chemicals**, is there **a concrete issue** in the lack of CLP labelling for certain consumer mixtures (*e.g.* divergent Member States approaches on fuel, accidents with fuel products)?

b2) If no concrete issues and/or practical impossibility and unenforceability to label certain chemicals supplied in bulk, **should CLP exempt them from labelling**, or, alternatively, **introduce obligations to label only digitally** or via other means?

b3) **For re-fill chemicals**, should CLP introduce additional specific rules (stickers etc.)? Or go for digital labelling?



Format of labels

1. Multilingual labels (focus on fold-out labels)

2. Readability / Font size

Maximum number of languages?


Instead, provide labelling information in additional languages digitally?

(Preliminary) policy options (slide 1 of 2)

Regulations = CLP and Detergents Regulation

1) No new policy actions (baseline): no change, *i.e.* also no rules at all on e-labelling;

2) Non-legislative measures: Physical labels and voluntary use of e-label: all labelling requirements on physical label would remain. Commission guidance document on e-labelling;

3) Revision of the labelling rules in the regulations: align the two regulations and address inconsistencies on the physical label only;

(Preliminary) policy options (slide 2 of 2)

4) Revision of the labelling rules in the regulations, introducing optional digital labelling: All requirements for the physical label would remain. A framework set up within CLP would regulate the optional use of digital labelling, *i.e.* to provide the *option* to move certain (mandatory) labelling requirements on the e-label only;

5) Revision of the labelling rules in the regulations, introducing optional digital labelling: All relevant requirements for the physical label would remain. A framework set up within CLP would regulate the optional use of digital labelling, *i.e.* to provide the *option* to move further (mandatory) labelling requirements on the e-label only;

6) Revision of the labelling rules in the regulations, providing for digital labelling only in specific cases (to be kept in mind for products which currently ¹⁸do not bear a label at all).
